REACH DECLARATION

Branch "Khimvolokno Plant" of Joint Stock Company "Grodno Azot" (hereinafter Branch "Khimvolokno Plant") undertakes to fulfill the requirements of Regulation (EC) No 1907/2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (hereinafter REACH Regulation) in relation to the products exported to the EU countries: polyamide 6 (falls into the category "polymer"), polymer composite materials (fall into the category "mixture"), chemical fibers, cord fabric (fall into the category "articles").

According to Article 2(9) of the EU REACH Regulation, polymers are not subject to registration.

Monomer (ϵ -caprolactam) for production of polyamide 6 virgin non-thermostabilized (in the form of granules) was registered by the Sole representative of JSC "Grodno Azot" in the European Union, BNH-Oil Polska Sp. z o.o. (registration No. 01-2119457029-36-0013).

The products manufactured by Branch "Khimvolokno Plant" are not subject to any registration obligations and do not contain the substances intended for intentional release under normal or specially estimated conditions of use (according to the requirements of Article 7 (1) of the REACH Regulation).

Branch "Khimvolokno Plant" declares that the products exported to the EU countries do not contain:

- substances of very high concern (SVHC) in concentrations exceeding 0,1 % (wt) mentioned in the SVHC Candidate List, updated on the 25th of June, 2025 (<https://www.echa.europa.eu/-/echa-adds-three-hazardous-chemicals-to-the-candidate-list>);
- substances listed in the actual Annex XVII of the REACH Regulation;

If one of our products contains substances of very high concern (SVHC) in concentrations exceeding 0,1 % (wt) or substances listed in Annex XVII of the REACH Regulation, we will inform our customers about these chemicals, considering the requirements stated in Article 33 of the REACH Regulation.

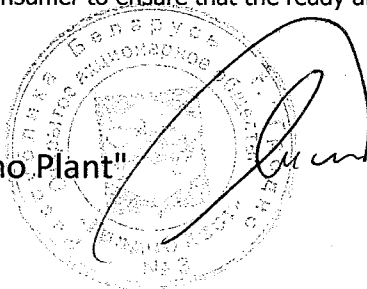
When supplying to the EU countries new types of products for which it is necessary to fulfill the registration requirements of the REACH Regulation, these requirements will be fulfilled as established by the REACH Regulation.

This REACH Declaration has been accepted based on our understanding of the REACH Regulation.

All information provided for by Branch "Khimvolokno Plant" regarding its products is considered to be reliable, however Branch "Khimvolokno Plant" is not responsible for their further processing, as well as for establishing the conformity of the final product with national and international regulations concerning its field of application.
